OVERVIEW

The requirements for earning of the award are outlined in the Scout Handbook. All requirements must be met while in Scouts or during the overlap period in Venturers. Activities while in the Cub Pack do not apply.

Scouts applying for this award must complete the "Resume of Scout Activities" sheet as well as arrange for the necessary signatures on his application sheet.

The Scouter's signature would follow a resolution by the Troop to ensure that the Scout's peers feel that the applicant is deserving of the Award and verify that all requirements have been met.

Approval by the Commissioner or delegate is not required before presentation of the award. The Area Commissioner or delegate will interview each recipient to ensure that the Scout has the right attitude about Scouting and about the Award but will not be an examiner of any of the requirements. However, if in due course of the interview the facts come out that the Scout is not properly qualified, for whatever reason, the Commissioner may not approve the Award.

A form letter signed by the Scouter shall be sent with the Scout to an interested citizen, outside of scouting, of the Scout's choice. The citizen will interview the Scout and comment, in the space provided on the letter, as to how the citizen perceives the Scout as both a Scout and a Citizen.

The certificate will be presented to the Scout at a ceremony in June of each year. To be sure that the invitations and plans for the Scout are out in proper time, all forms and interviews must be completed by the End of March. Any applications, forms, or requests for interviews received after that time will be processed for presentation the following year, except by special arrangement.
